Enter the correct amount or zero.• Enter Federal School Code: 001587: Paine College, Augusta, GA 30901-3182, in Step Six.• Print the FAFSA and the FAFSA on the Web Submission Confirmation page as proof of filing.

√ 2009 FEDERAL INCOME TAX RETURN	REQUIRED: ALL STUDENTS, IF SELECTED FOR VERIFICATION <ul style="list-style-type: none">• <u>Sign and date</u> photocopies of 1040, 1040A or 1040EZ forms before submitting.• IRS Form 8453 "(U.S. Individual Income Tax Declaration for an IRS e-file Return)" is not acceptable.• 1040 filing extensions and state tax returns are <u>not</u> accepted in place of required federal tax forms.• Write the <u>student's name and Social Security Number</u> on photocopies of all tax documents.• Dependent students must submit their parents' federal income tax returns.• Independent students, if married, must submit your spouse's federal income tax return if he/she filed separately.
√ 2009 GEORGIA STATE INCOME TAX RETURN	REQUIRED: ALL NEW AND TRANSFER STUDENTS THAT ARE GEORGIA RESIDENTS <ul style="list-style-type: none">• <u>Sign and date</u> photocopies of the state tax return forms before submitting.• Georgia Individual Income Tax Declaration for Electronic Filing is not acceptable.
√ 2010-2011 GA HOPE SCHOLARSHIP AND GA TUITION EQUALIZATION APPLICATION	REQUIRED: ALL NEW AND TRANSFER STUDENTS THAT ARE GEORGIA RESIDENTS - APPLY ONLINE AT www.GAcollge411.org.
√ 2010-2011 VERIFICATION WORKSHEET	REQUIRED: ALL STUDENTS, IF SELECTED FOR VERIFICATION Always include the applicant. Include other family members who meet the criteria listed on the form.
√ ADDITIONAL DOCUMENTATION	REQUIRED: If requested, supply additional information, forms, or documentation for verification or to clear up any questions.

IMPORTANT: All of the above required documents must be accurate, signed, processed and received in the Financial Aid Office no later than **MARCH 1, 2010** for **PRIORITY CONSIDERATION** for all **FALL 2010 awards**. In addition, **SATISFACTORY ACADEMIC PROGRESS** standards must be met. Documents received after March 1, 2010 may result in a significant decrease in financial assistance for the 2010-2011 academic year.
